## ***HISTORY***

Bering Land Bridge National Preserve, located on the Seward Peninsula in northwest Alaska, is considered one of the most remote National Park Service (NPS) units. This national preserve protects a remnant of the Bering Land Bridge which connected Asia with North America. The primary purpose of this NPS unit is to protect and preserve for research and interpretation a portion of the 1,000-mile-wide land link that intermittently connected Asia and North America 14,000-25,000 years ago. The land bridge is now overlain by the Chukchi and Bering Seas. The entire land and maritime area from northwest Alaska to Russia is also commonly referred to as Beringia. Approximately 2.8 million acres are included in this national preserve, and these lands contain paleontological deposits that can be studied and analyzed to determine the climate and conditions that existed when plants and animals migrated between the North American and Asian continents. The archeological record on the preserve has abundant evidence of man's early habitation in northwest Alaska.

In 1978, Bering Land Bridge, along with numerous other Alaska parks, was established as a national monument by Presidential proclamation. The designation was modified in 1980 as part of the Alaska National Interest Lands Conservation Act (ANILCA), and the monument was redesignated as a national preserve. At the time, the four NPS units in northwest Alaska were grouped as one administrative unit, Northwest Alaska Areas (NWAK), which is now referred to as the Western Arctic National Parklands (WEAR). BELA is one of those four park units, and the other three units are Cape Krusenstern National Monument (CAKR), Kobuk Valley National Park (KOVA), and Noatak National Preserve (NOAT). BELA is currently managed separately and is no longer administered as part of WEAR.

BELA contains biological, geological, and archeological resources of great significance, and is home to many large and small mammals, over 170 migratory bird species, and more than 300 species of vascular plants, small trees, and shrubs. There are no roads within the preserve, and the nearest town is Kotzebue, 94 miles to the east. The traditional villages of Shishmaref, Deering, and Wales sit just outside the preserve boundary. Residents of these villages consider the preserve their backyard for subsistence and hunting activities, which are allowed in the preserve as established under the provisions of ANILCA. Visitors can enjoy vast expanses of undeveloped backcountry and experience wonders such as the Serpentine Hot Springs, the Chukchi Sea Coast, Kuzitrin and the Twin Calderas, the maar lakes, Imuruk Lake, and Imuruk Lava Beds.

The U.S. Congress acknowledged that the shared cultural and natural heritage of the Beringia region and the reestablishment of ties between people in Beringia was important, and in 1991 directed funding to the National Park Service to establish the Shared Beringian Heritage Program (SBHP). The program annually funds between 12 and 20 natural or cultural resource projects; works to improve local, national, and international understanding of the resources; and works to sustain the cultural vitality of Native peoples in the region. Many of the projects

funded by the program pertain to natural and cultural resources in BELA. The SBHP is currently administered by BELA but is a regional program that was initially managed by the Alaska Regional Office. As such, the records of the SBHP are maintained as part of the Alaska Regional Curatorial Center (ARCC) collection. The ARCC is both the name of the collection of the Alaska Regional Office and the regional multi-park collections storage facility based in Anchorage.

The archives which are described in this finding aid contain associated records and resource management records relating to BELA. The archives for the WEAR park units are described in separate finding aids but may contain information relevant to the administration of BELA during the period when BELA was managed as part of NWAK/WEAR. Additionally, the ARCC collection also contains records related to resources within BELA. The BELA, ARCC, and WEAR archival collections are housed at the Alaska Regional Curatorial Center (ARCC) in Anchorage.

<i>DESCRIPTION</i>	This collection consists of the records of Bering Land Bridge National Preserve. The records document the management of natural and cultural resources in the preserve as well as park operations. Records include correspondence, reports, articles, photographic material, permits, maps, journals, logbooks, data sheets, specimen inventories, field notes, audiovisual recordings, and digital records. Digital records in word processing formats, spreadsheet and database formats, image formats, and a variety of other formats are housed on a preservation server. This collection also includes print photographs, slides, and negatives which depict various aspects of park management and other activities.

## ***SERIES DESCRIPTIONS***

### **SERIES I: Administrative Records, 1967-2015, undated**

The series is organized into two subseries: 1. Program Files, 2. Reports.

Administration records contain documents relating to park operations, planning, and procedures.

#### *SUBSERIES I-A: Program Files, 1967-2015, undated*

Arranged by date.

Program files include correspondence, plans and studies related to management and planning. Of note are several visitor logs from Serpentine Hot Springs which document use and also include observations on wildlife and weather.

#### *SUBSERIES I-B: Reports, 1973-2009*

Arranged by date.

Reports include the park Master Plan, Environmental Impact Statements, and General Management Plan, which help guide long-term park planning and operations.

### **SERIES II: Concessions, 1991-2012**

Arranged by date.

This series includes correspondence and reports related to the establishment of a hunting guide system for the park.

### **SERIES III: Interpretation, 1973-1988**

The series was previously organized into two subseries: 1. Program Files. 2. Photographic Material. See scope note for series 1 for additional information.

The series consists of material that is used to facilitate public communication about the park, primarily photographic material that documents park resources and activities.

#### *SUBSERIES III-A: Program Files (Superseded)*

The files in this subseries were recataloged into Cultural Resources projects in 2022 because they pertained to publication of cultural resources reports.

#### *SUBSERIES III-B: Photographic Materials, 1973-1988*

The photographic material is organized into two sub-subseries: 1. National Visual Inventory Cards and 2. Alaska Task Force Slides.

Park places, people, and resources are documented in these images. Some were collected by the Alaska Task Force during its assessment of proposed national parklands in the late 1970s. Others were collected for the National Visual Inventory.

*SUB-SUBSERIES III-B-1: National Visual Inventory Photo Cards, 1987-1988*

Arranged by subject and then by negative or classification number.

This sub-subseries contains National Park Service National Visual Inventory photo cards for Bering Land Bridge National Preserve. The cards contain subject information, location, photographer name, date, and identification numbers. The subjects include Archeology, Artifacts, Landforms, Structures, Mining, and Tools and Equipment.

*SUB-SUBSERIES III-B-2: Alaska Task Force Slides, 1973-1974, 1978*

Arranged by roll number.

Slides document geologic and landscape features, vegetation, and subsistence activities. The slides are stamped as being duplicates of park master slides and are annotated with descriptive information.

**SERIES IV: Law Enforcement (Superseded)**

Files previously included in the Law Enforcement series were recataloged into the Cultural Resources series in 2022 because they all pertained to archeological disturbances.

**SERIES V: Maintenance, Planning, and Design (Superseded)**

Files previously included in the Maintenance, Planning, and Design subseries were transferred to the NPS Technical Information Center (TIC) in 2022.

**SERIES VI: Resources, 1902-2021 (bulk: 1975-2021)**

The Resources series is organized into two subseries: 1. Natural Resources. 2. Cultural Resources. Series 3 (Museum Management) and Series 4 (Reports) have been superseded.

This series includes information regarding the management, documentation, and preservation of natural and cultural resources in the Bering Land Bridge National Preserve. Records were created both by Park Service personnel and non-NPS researchers.

*SUBSERIES VI-A: Natural Resources, 1903-2019, undated (bulk: 1977-2004)*

The Natural Resources subseries is organized into twelve sub-subseries: 1. Program Files. 2. Reindeer. 3. Fish. 4. Plants. 5. Water. 6. Weather and Climate. 7. Geology. 8. Environmental Cleanup. 9. Fire. 10. Field Reports and Notes. 11. Permits (superseded). 12. Aerial Photographs.

This subseries contains material relating to the management, documentation, and preservation of natural resources, including land management, fire management, biological studies, and physical resource studies. Natural Resource program files contain records relating to operations of the programs, including correspondence, trip reports, meeting minutes, annual reports, and policy and management information.

*SUB-SUBSERIES VI-A-1: Program Files, 1903-2005, undated (bulk: 1977-2005)*

Arranged by date.

The Program files contain correspondence and information about natural resource management, including records that relate to more than one of the other sub-topics included in the series.

*SUB-SUBSERIES VI-A-2: Reindeer, 1968-2002, undated (bulk: 1980-1999)*

Arranged by date.

Reindeer files consist of reindeer tracking field projects and related correspondence and project planning files. Also included is reference material regarding historic reindeer herding and population trends.

*SUB-SUBSERIES VI-A-3: Fish, 1993-2004, undated*

Arranged by date.

The fish records contain documents, data sheets, inventories, meeting notes and plans regarding fish research and projects. A significant portion of the records relate to the Norton Sound Research and Restoration project which was an interagency project concerning the management of chum salmon runs in Norton Sound.

*SUB-SUBSERIES VI-A-4: Plants, 1985-2004, undated*

Arranged by date.

The plant records include plant lists, meeting minutes, collection and survey data, descriptions, and guidelines.

*SUB-SUBSERIES VI-A-5: Water, 1981-2004, undated*

Arranged by date.

Water resource records include reports and plans, data forms and correspondence. Subjects of the files include management, water rights, and water quality.

*SUB-SUBSERIES VI-A-6: Weather and Climate, 1945-1995 (bulk: 1989-1995)*

Arranged by date.

The weather and climate files consist of records and measurements, summaries, and plans.

*SUB-SUBSERIES VI-A-7: Geology, 1977-2019 (bulk: 1985-2019)*

Arranged by date.

The geology files include documents concerning geology and related fields such as paleontology and volcanology. Records include maps, studies, correspondence, and photographs.

*SUB-SUBSERIES VI-A-8: Environmental Cleanup, 1974-2003*

Arranged by date.

Environmental cleanup files include legal regulations, plans, and photo logs. Files within this sub-series involve environmental concerns and hazards affecting the park. Proactive plans and regulations are included, as well as compliance and site summaries, surveys, and cleanup and closure incidents.

*SUB-SUBSERIES VI-A-9: Fire, 1977-2002, undated (bulk: 1985-1991)*

Arranged by date.

The fire files contain reference material, documentation forms, memos, correspondence, and reports. A significant portion of the files are documentation forms which record fire activity and response. Other material relates to fires and firefighting techniques, fire management, and landcover.

*SUB-SUBSERIES VI-A-10: Field Reports, 1985-1993*

Arranged by date.

This sub-subseries was created for projects which span more than one specific natural or cultural resource area or discipline. Included are reports, logbooks, data sheets, and specimen lists. One significant project documented is the Resource Inventory and Voucher Collection project which began in 1987.

*SUB-SUBSERIES VI-A-11: Permits (Superseded)*

The permits in this sub-subseries were recataloged in 2022 into other Natural Resources or Cultural Resources series relevant to the permitted activity or research.

*SUB-SUBSERIES VI-A-12: Aerial Photographs, 1995*

Arranged by frame number.

The aerial photograph sub-subseries consists of 88 black and white prints of Cape Espenberg taken on 7/26/1995 for the coastal erosion monitoring program. Some of the aerials are annotated.

*SUBSERIES VI-B: Cultural Resources, 1902-2021 (bulk: 1975-2021)*

The Cultural Resources subseries is organized into five sub-subseries: 1. Program Files. 2. List of Classified Structures. 3. Compliance. 4. Allotments. 5. Projects.

This subseries contains files produced by park Cultural Resource staff or by outside contractors and researchers. Material relates to the documentation and management of cultural resources including archeological, historical, and ethnographic projects and programs.

*SUB-SUBSERIES VI-B-1: Program Files, 1920-2010, undated (bulk: 1982-2010)*

Arranged by date.

Cultural Resource program files include correspondence, maps, notes, photographs, and reports. Subjects pertain to program operations, resource evaluations, grants, and National Register activities.

*SUB-SUBSERIES VI-B-2: Historic Structures, 1975-2010, undated*

Original order of the files has been maintained, which is mostly chronological.

This sub-subseries contains survey forms and notes documenting historic structures or sites in the preserve that are included or potentially eligible for the List of Classified Structures, which is an

evaluated inventory of all structures that have historical, architectural, and/or engineering significance within the National Park System.

*SUB-SUBSERIES VI-B-3: Compliance, 1982-2010*

Arranged by date.

In compliance with applicable laws such as the National Historic Preservation Act and the National Environmental Protection Act, clearance is required prior to any undertaking within park lands which may have an adverse effect or impact on natural or cultural resources. The compliance process facilitates the assessment of positive or negative impacts that a proposed project may have on the environment. This subseries includes compliance documents, reports, and correspondence pertinent to the process.

*SUB-SUBSERIES VI-B-4: Land Allotments, 1999-2008*

Arranged by date.

The allotment files are composed of applications for Native allotments and related correspondence, as well as information on real estate dealings and land status.

*SUB-SUBSERIES VI-B-5: Projects, 1902-2021 (bulk: 1975-2021)*

The sub-subseries is organized into five sub-sub-subseries: A. Archeological Data Recovery Project. B. Cultural Sites Inventory. C. Kitluk River Mouth Site Data Recovery Project. D. Other Projects. E. Cape Espenberg Projects.

Cultural Resource project records contain inventory forms, site forms, data sheets, analysis records, excavation notes, maps, and photographs.

*SUB-SUB-SUBSERIES VI-B-5-a: Archeological Data Recovery Project, 1975-2009 (bulk: 1988-1991)*

Arranged by record type, then by archeological site locations, which are assigned by the State of Alaska according to the site's location on one of four USGS quadrangle maps. The quadrangles are Bendeleben (BEN), Kotzebue (KTZ), Shishmaref (SHF), and Teller (TEL). Within quadrangles, sites are arranged numerically by state site number. Artifact analysis documentation cards are arranged by artifact number. Images are arranged according to roll numbers, which correspond with various phases of the project.

This sub-sub-subseries contains materials produced during the park's Archeological Data Recovery Project (ADRP). These materials include accession catalogs, faunal analysis records, field notes and photo logs, photographs, research notes, database files, site maps and data, correspondence, artifact analysis documentation cards, and reports. The project focused on sites that were determined during the Cultural Sites Inventory (CSI) to be in danger of data loss due to vandalism or natural turbations. See series VI-B-5-2 for records of the CSI.

*SUB-SUB-SUBSERIES VI-B-5-b: Cultural Sites Inventory, 1902-2011 (bulk: 1975-2011)*

Arranged by archeological site locations, which are assigned by the State of Alaska according to the site's location on one of four USGS quadrangle maps. The quadrangles are Bendeleben (BEN), Kotzebue (KTZ),

Shishmaref (SHF), and Teller (TEL). Within quadrangles, sites are arranged numerically by state site number.

This sub-sub-subseries contains documentation produced during the park's Cultural Sites Inventory (CSI) which began in 1985. The purpose of this inventory was to determine which sites were in danger due to vandalism and natural turbations, thus requiring urgent data recovery. While most sites have only one corresponding folder, over forty folders are dedicated to site BEN-085 (Serpentine Hot Springs) due to its nominations for the National Register of Historic Places (NRHP) and as a Traditional Cultural Property (TCP), as well as controversies surrounding access and use. Included in this sub-sub-subseries are reports, maps, and photographs.

*SUB-SUB-SUBSERIES VI-B-5-c: Kitluk River Mouth Site Data Recovery Project, 1993-1996*

Arranged by date, except for the artifact analysis documentation cards which are in order according to the identification numbers assigned during analysis.

This sub-sub-subseries contains documentation produced during, and as a result of, 1993 data mitigation excavations conducted by the National Park Service Alaska Regional Office. During a 1986 survey, KTZ-145, the Kitluk River Mouth Site, was determined to be a low priority site for archeological data mitigation. In the following years, as new information regarding the site's importance arose, in conjunction with accelerated erosion, it was re-prioritized, leading to the 1993 excavations. The material is composed of artifact lists, faunal analysis data, artifact analysis documentation cards, photographs, and maps.

*SUB-SUB-SUBSERIES VI-B-5-d: Other Projects, 1917-2021 (bulk: 2004-2021)*

Arranged by project and thereunder by date.

This sub-sub-subseries contains records of other Cultural Resources research and projects undertaken either by Park Service personnel or outside researchers. Significant projects include the Iyat History Project, undertaken to complete a Traditional Cultural Property nomination for Iyat (also known as Serpentine Hot Springs); the 2007 archeological survey of KTZ-00032, BEN-00084, and BEN-00159/00160; and the Nuluk Project, which looked at historic climate variability and adaptation.

*SUB-SUB-SUBSERIES VI-B-5-e: Cape Espenberg Projects, 2007-2021*

Arranged by date.

This sub-sub-subseries contains records of archeological studies undertaken at Cape Espenberg, including research on climate change and the Arctic Small Tool tradition.

*SUBSERIES VI-C: Museum Management (Superseded)*

Files in the museum collection subseries were removed to museum program office files in 2022.

*SUBSERIES VI-D: Reports (Superseded)*

Reports and articles originally cataloged into this subseries were redistributed into other series, including Administration, Natural Resources, and Cultural Resources, in 2022.

**SERIES VII: Subsistence, 1977-2005**

Arranged by date.

The subseries contains material pertaining to management of subsistence activities in the preserve. Documents include meeting minutes, reports, and regulation guidance from local, state, and federal boards and councils. Annual reports and management documents for fisheries and game are also included.
