^{*} The Alexander Valle Grant as initially described included the lands on what became Pigeon's Ranch. The re-description and the 1860 Congressionally confirmed Valle grant greatly reduced the size of the claimed land (to 574 acres, later appealed and about doubled in size) and allowed only land *north* of Pecos Village in the Pecos River canyon, ten miles east of Pigeon's Ranch. Valle received patent to the land in 1864. Valle, as possessor of a grant claim, could not also claim public domain under the various homestead acts (in this case, a "donation lands claim"), thus forcing his sale of improvements at Pigeon's Ranch.
