Anyway, I am sending the requirements from memory, as I am away from my office (and my log) until the morning. I'll double check my log then and confirm with you.

1) acknowledge disputed datapoints not attributable to DBOC

- 2) remove data points from database
- 3) discontinue use of database because of bias
- 4) retract Becker et al. 2009
- 5) do not publish Becker et al. 2010
- 6) remove Becker and Press
- 7) apologize and acknowledge Goodman and Lunny correct

If possible, I'd like to discuss these with you before you distribute.
