- **April 22 - November 6, 2015:** Applications accepted October 1 - December 1, 2015. Notification of reservations will be made prior to January 1, 2016.
- **November 7, 2016 - April 14, 2017:** available at Cabin Camp 5 only. Applications accepted after March 1, 2015 on a first come, first serve basis.

Applications will be accepted throughout the season, once initial applications have been processed and groups have been placed.
