



2019/2020 California Sport Fishing Regulations: Smith River



What You Need to Know

The following sport fishing regulations (effective through 2/29/20) are *summarized* as a courtesy to anglers in Redwood National & State Parks. All sport fishing must be in accordance with California Department of Fish and Wildlife (CDFW) regulations and requires a California fishing license for anglers 16 years old and older.

** Hatchery trout or hatchery steelhead are those missing an adipose fin with healed scar. Wild fish have an intact adipose fin.

Stream Closures

Special Low Flow Conditions

From Oct. 1 through Jan. 31, the following stream reaches may be closed to angling for the periods Tuesday and Wednesday, Thursday and Friday, and/or Saturday through Monday when CDFW determines flow conditions are less than 600 cfs as measured at the Jedediah Smith Redwoods State Park gauging station: The main stem of Smith River from the mouth of Rowdy Creek to the mouth of Patrick Creek; the South Fork Smith River from

the mouth upstream approximately 1,000 feet to the County Road (George Tryon) Bridge and Craigs Creek to its confluence with Jones Creek; and the North Fork Smith River from the mouth to its confluence with Stony Creek.

Call CDFW’s low flow closure hotline at 707-822-3164 to check if Smith River will be open or closed to fishing. The recorded message is updated by 1:00 p.m. each Monday, Wednesday, and Friday.

Additional Info.

Silver (Coho) Salmon

Silver salmon are fully protected at the state and federal level as threatened fish. Coho may not be taken from any California waters. Incidentally hooked coho must be immediately released unharmed to the waters where they were hooked.

Stop Invasive Species

Before and after fishing, please remove all plant material from your boat and/or trailer.

North Coast Salmon Report Card

A North Coast Salmon Report Card is required to fish for salmon on the Smith River and its tributaries.

Steelhead Report Card

All anglers must have a Steelhead Report Card in their possession while fishing for or taking steelhead on the Smith River and its tributaries.
