River Planning at St. Croix National Scenic Riverway

The National Park Service (NPS) has begun a comprehensive river management plan planning process at the St. Croix National Scenic Riverway. The river plan, once complete, will guide NPS actions and decisions of the St. Croix and Namekagon rivers for the foreseeable future. Input and engagement from stakeholders, partners, and the public will help develop and build this plan.

The purpose of this river plan is to establish overall management direction to protect and enhance the values for which the St. Croix National Scenic Riverway was designated as a component of the National Wild and Scenic Rivers System and unit of the National Park Service. The rivers contain free-flowing condition, good water quality, and aquatic, cultural, recreational, riparian, scenic-aesthetic, and geologic values. The plan will identify river-specific desired conditions, user capacities, monitoring and data needs, land and facility development protocols, communication goals, and other management practices necessary for protecting and enhancing river values.

Listening Sessions

To kick-off the multi-year planning process, the NPS will hold five listening sessions in locations throughout the park in July 2023 (details on back). At each session, NPS staff will present a short presentation about the river plan and the planning process. After the presentation, NPS staff will be at designated stations to foster conversation, gather feedback, and answer questions. The presentation will be the same at each session and will also be available on the park's Planning, Environment and Public Comment website at <https://parkplanning.nps.gov/sacnriverplan> on July 20, 2023.
