COMPETITIVE COMMERCIAL SERVICE DAY ALLOCATION SELECTION

NOTE: The Commercial Service Day (CSD) Allocation Selection for non-stock services must be submitted in the CUA Portal as part of the CUA Application. Failure to submit CSD Selection will result in your application being withdrawn from consideration.

CSD Distribution: 100% of total available CSDs in a given location category (Wilderness Wide or Mount Whitney Management Area) will be distributed to selected CUAs in 2 separate subtotal groups, 'base' and 'competitive round'. Applicants can apply for and be awarded a base allocation in one or both location categories (Wilderness Wide and/or Mount Whitney Management Area).

In addition, applicants may elect to compete in as many as five (5) competitive rounds [three (3) Wilderness Wide and two (2) Mount Whitney Management Area]; however, a CUA awardee may receive a maximum of one additional competitive round CSD allocation in each location category. Competitive Rounds will be conducted consecutively in each location category, Wilderness Wide and Mount Whitney Management Area, beginning with high and moving sequentially to mid and/or low. If an applicant chooses to compete in multiple competitive rounds, the applicant will be awarded the highest category for which they are determined to be eligible based on their score, and be withdrawn from consideration for additional CSD category entries.

Provide in writing the following information in order to be evaluated for a 2026-2027 Wilderness CUA and CSD allocation. The applicant will only be considered for the allocation(s) they have selected in this Attachment. The applicant will not be considered for any allocation that they have not selected in this Attachment and will therefore be ineligible for that allocation for the duration of the 2026-2027 CUA cycle (2 year period) covered by this solicitation.

Step 1 Each Applicant selecting one or both CSD location categories will compete for a limited number of CUAs and a base CSD allocation in the selected location category.

I am applying for:

Non-Stock CSD base Allocation for Wilderness Wide - estimated 25 CSDs/Allocation. (Limited number issued.) Wilderness Wide CSDs can be used Wilderness Wide for the calendar year except in the Mount Whitney Management Area during wilderness permit quota period.

AND/OR

Non-Stock CSD base Allocation for Mount Whitney Management Area- estimated 5 CSDs/Allocation. (Limited number issued.) Mount Whitney Management Area CSDs can be used in Mount Whitney Management Area during the wilderness permit quota period and Wilderness Wide anytime.

Step 2 Applicants may elect to compete for additional CSD allocations in each location category to increase the total CSD award; contingent upon successful award of a CUA. Applicants are strongly encouraged to apply only for competitive round CSD allocation(s) that most closely match planned operating levels *and* any lower levels for which they wish to be considered.

I am also applying to compete for additional CSDs in the following competitive rounds:

Non-Stock Wilderness Wide CSD Allocation 'High'- estimated 415 CSDs/Allocation.

AND/OR

Non-Stock Wilderness Wide CSD Allocation 'Medium' - estimated 180 CSDs/Allocation.

AND/OR

Non-Stock Wilderness Wide CSD Allocation 'Low' - estimated 115 CSDs/Allocation.

AND/OR

Non-Stock Mount Whitney Management Area CSD Allocation 'High' - estimated 190 CSDs/Allocation.

AND/OR

Non-Stock Mount Whitney Management Area CSD Allocation 'Low' - estimated 55 CSDs/Allocation.

CSDs and allocations listed above are *ESTIMATED* and may vary based upon final number of CUAs awarded. Final determination of CSD allocations will be decided by the Service during the competitive process.
