Restrictions imposed under the discretionary authority of the Superintendent**

AUTHORITY


Under the authority of 16 USC (United States Code), Section 3, and Title 36 CFR (Code of Federal Regulations), Chapter 1, Parts 1-7, this Compendium of Superintendent's Orders is established for Shiloh National Military Park and National Cemetery. Regulations listed in this compendium are requirements in addition to those listed in Parts 1-7 of Title 36 CFR unless otherwise noted. The specific authority for this regulatory procedure is found in Section 1.5, through 1.7 of Title 36.

In addition to these regulations, the following are also provided:

Section 1.6(f) states that a list of those activities, which require a permit, must be maintained. That list appears in this document under 1.6.

As required by 1.7(b), these regulations, permit requirements and written determinations shall be updated annually and made available to the public upon request.

PURPOSE

Title 36 of the Code of Federal Regulations (CFR) Chapter 1, Parks, Forest and Public Property, has been established to provide for the proper use, management, government and protection of persons, property, and natural and cultural resources under the jurisdiction of the National Park Service (NPS). {36 CFR 1.1(b)}

Regulations within 36 CFR will be utilized to fulfill the statutory purposes of units of the National Park System: to conserve scenery, natural and historic objects, wildlife and to provide for the enjoyment of these resources in a manner that will leave them unimpaired for the enjoyment of future generations. {36 CFR 1.1(b)}

Within 36 CFR the park superintendent has the discretionary authority to establish regulations that are more or less restrictive than a given regulation in certain instances. The superintendent is required to compile in writing all the designations, closures, permit requirements and other restrictions imposed under discretionary authority. {36 CFR 1.7(b)}

All designations, closures, permit requirements and other restrictions are addressed in Parts 2, 3, 4, 5, 12, and 25 below under the appropriate section number and heading where they are applicable. Violations of compendium restrictions will subject a person to the same penalties for violating provisions of 36 CFR.

PUBLIC NOTICE and INFORMATION

In addition to the compendium, all designations, closures, permit requirements and other restrictions will be made available to the public by at least one other method of notification. Methods include maps, signs and publication in newspapers, handouts and other appropriate media. {36 CFR 1.7(a)}

Title 36 CFR and the Superintendent's Compendium are available for review at the Superintendent's office, Chief Ranger's office, Visitor Center and Corinth Interpretive Center information desks or through contact with a park ranger. Superintendent's Designations,
Closures, Permit Requirements and Restrictions

36 CFR PART 1 – GENERAL PROVISIONS

SECTION 1.5 – CLOSURE AND PUBLIC USE LIMITS

(a) (1) The following areas are closed to the public:

- Firing Range (when being used for training or qualification)
- Resource monitoring plots and survey sites
- NPS residence areas
- NPS maintenance facility

The grounds of Shiloh National Military Park, including the National Cemetery, Shiloh Indian Mounds NHL, and the Corinth Unit will be open to visitors daily from sunrise to sunset.

From sunset to sunrise, the use of park roads is limited to through traffic (non-recreational) and use by local residents.

The park is closed on Christmas Day, December 25th.

The following park buildings and other public use facilities will be open during the following hours.

- Shiloh Visitor Center – 8:00 a.m. until 5:00 p.m.
- Administration Office – 8:00 a.m. until 4:30 p.m. (Monday - Friday)
- Corinth Visitor Center – 8:00 a.m. until 5:00 p.m.

(a) (2) The following activities are prohibited at Shiloh National Military Park:

Any and all types of recreational games and activities (i.e., football, baseball, Frisbees, kite flying, etc.), except in the following areas: the picnic grounds, the residence area by NPS residents and their guests, and those areas authorized by permit through the superintendent or designee.

Walking, jogging or standing on park roads, whether one-way or two-way, so as to interfere with traffic.

SECTION 1.6 – PERMITS

The following activities require permits:

- Possession of a historic or replica weapon

Camping
Operating a Power Saw
Operating motorized equipment in a non-developed area
Removing a downed aircraft
Using, possessing or transporting explosives
Special events
Public assemblies
Selling or distributing printed matter
Grazing livestock or agricultural uses
Residing on park lands
Scattering of human ashes
Operating a vehicle exceeding load, weight or size
Displaying, posting or distributing advertisements
Conducting business operations
Commercial filming and photography
Operating a commercial vehicle
Constructing a temporary structure, trail or path
Burial in the national cemetery
Disinterment of remains from the National Cemetery
Memorialization
Conducting a tour for a fee
Collect research specimens

36 CFR PART 2 – RESOURCE PROTECTION, PUBLIC USE, AND RECREATION

SECTION 2.1 – PRESERVATION OF NATURAL, CULTURAL AND ARCHAEOLOGICAL RESOURCES

(a) Except otherwise provided the following is prohibited:

(4) The collecting of wood for personal use is authorized in approved locations only. Cleanup of limbs and debris will be the responsibility of the user.

(c)(2)(i) Fruits nuts and berries may be collected and consumed for personal consumption not to exceed one (1) bushel per person, per season, additional collection may be approved by permit only.

SECTION 2.3 – FISHING

(a) Fishing in the following areas is prohibited: Bloody Pond, Water Oaks Pond, and all creeks located within the park.

SECTION 2.10 – CAMPING AND STORAGE

- Camping or overnight use will be limited to special event personnel and restricted to locations approved by the superintendent or their designee.
- Permits for camping may be issued by the superintendent or designee for educational groups using the park for educational purposes as part of the school curriculum.

SECTION 2.11 – PICKNICKING

Historic Sowell Field has been established as the park's picnic area.

SECTION 2.13 – FIRES

Fires are prohibited except for the following activities and locations authorized by the superintendent:

- Cooking on grills at the picnic area in Sowell Field.
- Cooking and heating at permitted Living History locations.
- Cooking and heating at permitted campsites
- Prescribed burns.

Campfires will be made on the surface of the ground or in metal fire rings provided by the park.

SECTION 2.15 – PETS

(a) The following are prohibited:

- (4) Allowing a pet to threaten visitors by barking, growling, lunging, or other noise or action.

SECTION 2.21 – SMOKING

Smoking is permitted only in park residences.

SECTION 2.35 - ALCOHOLIC BEVERAGES AND CONTROLLED SUBSTANCES

The consumption and possession of alcoholic beverages is allowed only in the park residence area.

SECTION 2.50 – SPECIAL EVENTS

All non-NPS events will be required to obtain a permit from the superintendent or designee, and a fee or bond may be required of the group. There will be a meaningful association between the park area and the event(s), and the observance contributes to

visitor understanding of the significance of the park area. The amount of the fee will be determined at the time of permit issuance.

The permit must be applied for at least two weeks in advance of the event.

SECTION 2.51 – PUBLIC ASSEMBLIES, MEETINGS

Public assemblies, meetings, gatherings, demonstrations and alike will be authorized by permit obtained from the superintendent prior to the event requested.

The permit must be applied for at least two weeks in advance.

Public assemblies associated with First Amendment activities may be conducted at the following First Amendment areas designated by the superintendent: Shiloh Battlefield Unit (1) for activities of 25 people or less, at Silverfsparre's Illinois Battery Monument (located within sight of the Visitor Center, roughly 30 yards southwest of the entrance to the National Cemetery); (2) for activities of 26 people or more, at south Chambers field, 1/3 mile west of the Shiloh Battlefield Visitor Center on the Savannah – Pittsburg Landing (main entrance) road. For activities at the Corinth Unit: (1) for activities of 25 people or less, on level ground immediately south of the Corinth Civil War Interpretive Center flagpole; and (2) for activities of more than 26 people, on the level ground located east of historic Battery Robinett, situated on the grounds lying between the city streets of Linden (north), Fulton (east) and Waldron (south).

SECTION 2.62 – MEMORIALIZATION

- (a) Installation of a monument, memorial, tablet, structure, or other commemorative installation in the park is prohibited without the authorization of the Director.
- (b) The scattering of human ashes from cremation is prohibited, except by permit.

36 CFR PART 3 BOATING AND WATER ACTIVITIES

SECTION 3.6 – PROHIBITED OPERATION

Launching or operating vessels upon or within the water areas of Shiloh National Military Park is prohibited. Vessels may operate on the Tennessee River in accordance with state and federal law.

SECTION 3.21 – SWIMMING AND BATHING

Swimming, tubing, bathing, diving and wading in waters within Shiloh National Military Park are prohibited.

36 CFR PART 4 MOTOR VEHICLE LAWS

SECTION 4.10 – TRAVEL ON PARK ROADS AND DESIGNATED ROUTES

- (a) All vehicle traffic is limited to paved park roads. Parking is permitted along road edges immediately adjacent to paved surfaces. However, parked vehicles may not interfere with the free flow of traffic. No roadside parking allowed beginning at the Indian Mounds Pavilion and continuing east for one-quarter mile.

SECTION 4.21 – SPEED LIMITS

The maximum speed limit on Tennessee State Highway 22 and Highway 142 is 45 mph. The speed limited on all other park roads is 25 mph unless otherwise posted.
