<ul style="list-style-type: none"><li>○ No services will be provided on the island and all hunters will need to arrange their own transportation and bring all supplies <b>INCLUDING DRINKING WATER</b>, or bring a water purification device.</li></ul>
<ul style="list-style-type: none"><li>○ There is <b>no bag limit</b> on the number or sex of deer that can be taken.</li></ul>
<ul style="list-style-type: none"><li>○ The <b>firearm and muzzleloader</b> seasons have been combined into one hunt.</li></ul>
<ul style="list-style-type: none"><li>○ All hunters are required to check in with the rangers upon arrival on the island, attend the ranger orientation, and obtain a backcountry permit.</li></ul>

Bow	October 1 through 28, 2011
Firearm (Muzzleloader and Rifle)	October 29 through November 6, 2011.
- **A NON-REFUNDABLE \$25.00 APPLICATION FEE IS REQUIRED FOR THE HUNT PERIOD BEFORE A PERMIT CAN BE PROCESSED. GROUPS MAY SEND ONE CHECK FOR ALL HUNTERS IF THEY PREFER. MAKE CHECKS (FOR THE EXACT AMOUNT ONLY) PAYABLE TO: NATIONAL PARK SERVICE.**
- Only one hunter per application
- You may apply for both a bow or muzzleloader/firearm hunt; however, you must have a 2011 Michigan deer license which corresponds with the type of North Manitou hunt that you are applying for:
- ENTER LICENSE NUMBER
  - BOW \_\_\_\_\_
  - FIREARM \_\_\_\_\_  
(Includes Muzzleloader)
- **There is no bag limit on the number or sex of the deer that can be taken. Deer taken legally on North Manitou Island shall not count against the hunter's regular deer season bag limit on the mainland. Park rangers shall affix a special North Manitou Island deer seal to each legally taken deer by the time the hunter leaves the island with the deer.**
- **Carefully review the attached information sheet as there are several changes in the hunt this year.**
