The Eleventh was assigned to the Third Brigade, Second Division, Army of the Cumberland.

From Nashville the regiment was sent into East Tennessee, a part of the companies being assigned to the duty of guarding the Chattanooga and Knoxville railroad, and a part were stationed at Cleveland.

After two months' service in East Tennessee, the Eleventh was ordered to report to General Steedman at Knoxville, where it remained until August, and then proceeded to Nashville, where it was mustered out of service Sept. 16.

It returned to Jackson, Mich., Aug. 23, 1865, where it was paid off and disbanded.
