James S Foster late of Capt [sic] Porter C Olson Company F of the 36th Regt. Ill Vol Inft [sic] was inlisted [sic] by Porter C Olson on the 14th day of Aug 1861, to serve three years, was born in Chechequan, [sic] Bradford County, State of Pa., is 25 years of age, 5 feet 4 ½ inches high, fair complexion, grey eyes, dark hair, and by occupation when inlisted [sic] a Farmer. The Said James S Foster was killed in the battle of Murfreesboro Tenn [sic] Dec., 31 1862.

His effects were all lost on the battlefield.
