Twenty-sixth Regiment Ohio Volunteer Infantry.

THREE YEARS' SERVICE.

This Regiment was organized at Camp Chase, Columbus, Ohio, from June 10 to July 24, 1861, to serve three years. On the expiration of its term of service the original members (except veterans) were mustered out. The members of the Ninety-seventh Regiment, Ohio Infantry, whose term of service had not expired at the date of muster-out of that Regiment, were transferred to this Regiment June 10, 1865. The organization, composed of veterans and recruits, remained in service until October 21, 1865, when it was mustered out in accordance with orders from the War Department.
