## THREE YEARS' SERVICE.

THIS Regiment was organized at Camp Dennison, Ohio, June 20, 1861, to serve three years. It was mustered out June 21, 1864, by reason of expiration of term of service.

The official list of battles of this Regiment is not yet published in orders of the United States War Department; but the following list of battles in which the Regiment bore an honorable part is the most accurate that could be prepared from the various sources of information at our command. It first engaged the enemy at Middle Creek Fork, West Virginia, and remained constantly in active service until its capture by General Forrest and his Rebel Cavalry, in May, 1863.
