Transfer Letter

Madison Fla. June 12, 1863

Gen Beauregard

Charleston

Sir:

I am a member of the 4th Fla Regt Brickinridge [sic] Division- Was taken prisoner at the battle of Murfreesboro and suffered very much in health- Having been afflicted with asthma from infancy - there are very few days that I do not experience some difficulty in breathing and frequently have severe panic [illegible]- I removed from North Carolina to Florida on this account-

Having been engaged in the practice of Law for several years in this judicial district I have a large amount of unsettled business My lap already has been heavy- If I were in service in the State I could see after my own business to some extent. I have a dellicate [sic] wife and four children. A young man without family has consented to exchange places with me and has asked a transfer to my Regt.- General Cobb promised me to endorse the application and suggested that I had better state to you the grounds upon which I desired to be transfered [sic] to your Department

The transfer will be effected, if approved by you, without expense to the Confederate States- I have made arrangements with Capt [sic] [illegible] to pay the expenses of the young man to Misisippi [sic] or Tennessee

The application for Exchange and Transfer will reach you by the time you receive this and I will be very grateful for your approval. With the highest regard


