

many soldiers saw service in more than one regiment, and as the appropriation contemplated but one volume to each man, the entire history of the soldier has been compiled under his name and placed in the volume where he served longest. The primary object of the whole work has been to group the comrades who served in the same regiment, with names arranged in alphabetical order, and present him with the volume containing his own military history and the history of those with whom he served.

The soldiers who enlisted for three years and after serving two years re-enlisted in the field for "three years or during the war," have the distinctive and honorable title of "veteran" placed after their names.

Careful enumeration has been made of the total enrollment of each regiment, together with the list of casualties.

The work of compiling these individual histories has been long and arduous, but it has been one of gratification and satisfaction to record the gallant deeds of Michigan men who contributed so gloriously to the unity and perpetuity of the Union.

Fourth Cavalry.

The Fourth Cavalry was organized at Detroit and was mustered into the United States service Aug. 29, 1862. After entering the field it was brigaded with the Third Kentucky Cavalry, the Seventh Pennsylvania and the Second Indiana. These regiments served in this brigade during the war, and whatever assignment it was given in the division or corps was always known as "Minty's Brigade," and became as famous in the west as did the "Michigan Cavalry Brigade" in the east.

Robert H. G. Minty was Major in the Second Cavalry in 1861, Lieutenant Colonel of the Third Cavalry a few days afterward, and was made Colonel of the Fourth Cavalry July, 1862. He commanded the brigade of which the Fourth Michigan formed a part a greater portion of the time during its service in the field.

The Fourth left Detroit Sept. 26, 1862, for Louisville, Ky., with an enrollment of 1233 officers and men.

In October the regiment saw its first real service in an engagement with the confederate General John Morgan at Stanford, Ky., and drove

him and his forces to Crab Orchard, Ky., taking a number of prisoners. From this time to the end of the year the Fourth was constantly on duty, taking the advance of the Union forces from Nashville, upon Triune, Franklin, Lavergne and other points leading out from Nashville, and making reconnoissances and scouts in every direction, meeting the enemy almost daily and invariably was victor when not overwhelmed by superior numbers.

During these months of active service the regiment as a whole, or by detachments, made a number of saber charges with brilliant success, which was somewhat unusual at that period of the war, or fought on foot with the facility of veteran infantry when occasion required. It routed the enemy on many a field and captured prisoners and destroyed vast amounts of public property which the south could ill afford to lose.

In January, 1863, though the weather was severe and the roads almost impassable and rations scarce, the regiment started from Murfreesboro for the Harpeth River, met Forest's and Wheeler's Cavalry and drove them back with considerable loss of killed, wounded and prisoners.

The following month the regiment was in pursuit of Wheeler and Forest near Fort Donelson, captured two officers of Forest's staff and a number of his men, besides wagons loaded with supplies. During this march of 280 miles in snow, sleet and rain the regiment captured 145 prisoners and 14 commissioned officers.

March 4th the regiment, with its brigade, was a part of General Sheridan's forces, moved out of Murfreesboro toward Shelbyville and Franklin and during the next ten days was in constant contacts with the enemy, finally driving him across Duck River.

After a short rest at Murfreesboro the regiment, with the cavalry forces, moved upon McMinnville. Near this place the Fourth burned an important railroad bridge and captured and appropriated or destroyed a vast amount of quartermaster stores and commissary supplies belonging to the confederates. The regiment returned to Murfreesboro on the 26th, having marched 328 miles and captured 150 prisoners.

During the month of April the Fourth took part in a number of expeditions, when it moved out of Murfreesboro, some of them of a very hazardous nature, but always acquitted itself in a manner to receive the highest praise of its commanding officers.

On the 22d day of May, 1863, the regiment, with its brigade, marched to Middleton, and the Fourth charged through the town and a mile beyond, where it met the First Alabama. Quickly dismounting and advancing on the camp with their repeating rifles, the confederates fled and the Fourth took possession, capturing the flag of the First Alabama and destroying a large amount of small arms, ammunition, saddles and clothing. The flag, by resolution of the regiment, was presented to the Governor of Michigan and is now deposited in the Military Museum at the Capitol.

During the month of June the regiment made several important movements and met the enemy, consisting mostly of Morgan's command, on the Manchester pike and drove him across Stone River again at Spring Creek, Alexandria, Guy's Gap and at Shelbyville drove the confederates under General Wheeler into and across Duck River, where a large number were drowned or killed, and the brigade captured three pieces of artillery and 200 prisoners. The following two months the regiment made a number of reconnoissances and on the 8th of August charged General Debel's confederates at Sparta, routing him, and reached McMinnville on the 10th.

The Fourth started the 17th of August, under the direction of General Rosecranz, for Sequatchie Valley, on the Chattanooga campaign. The regiment occupied Chattanooga in September and scouted the country as far as Lee and Gordon's Mills and Crawfish Springs. On the 15th it crossed the Chickamauga River over Reed's Bridge and proceeded to near Ringgold to watch the operations of the enemy. Here Colonel Minty was informed that the confederate forces under Forest were at Ringgold, Longstreet at Dalton, Pegram at Leets and Buckner at Rock Springs.

The 16th and 17th the Fourth, with its brigade, skirmished with the enemy and on the 18th the confederate infantry advanced and slowly pushed the cavalry across the Chickamauga, though the ground was stubbornly defended, and the enemy detained from crossing to the west side until the following morning. When Colonel Minty reported to Major General Crittenden that the enemy's infantry in force was in the immediate vicinity and was about to cross the Chickamauga and attack the Union forces the story seemed too incredible to believe. But General Crittenden found to his cost the following morning that Colonel Minty's report was correct and that Bragg's army was in position to attack and was already moving.

The battle of Chickamauga was fought on the 19th and 20th, and for severity and loss was scarcely equaled by any battle of the civil war, considering the number of forces engaged.

During the night of the 20th the Union forces were withdrawn from the field as far as Rossville, but the Michigan Cavalry Brigade did not pass through the Gap and return upon Chattanooga until the 22d.

Early in October the confederate General Wheeler started on a raid in rear of the Union army, and the Fourth, with its brigade, went in pursuit. The march was a long and weary one, first crossing Woldren's Ridge, then through the Cumberland Mountains to McMinnville, Murfreesboro, Pulaski, thence to Huntsville, New Market and Maysville, Ala., and retired to Chattanooga, the 21st.

During the remaining months of the year the Fourth was constantly in the saddle, making long marches, fighting the enemy and capturing and destroying immense stores of public property.

The regiment was at Pulaski, Tenn., in January, 1864, and again proceeded to Chattanooga. From this point numerous reconnoissances were made to Summersville, Dalton, Ringgold, Tunnel Hill and the Etowah.

Returning from Etowah to Chattanooga, the regiment was sent by rail to Nashville, where it received new equipments and was armed with the Spencer carbine.

In April, 1864, the Fourth marched across the Cumberland Mountains to the vicinity of Chattanooga and then crossing Lookout Mountain and Taylor's Ridge attacked the enemy at Rome, Ga., on the 15th, where it routed a confederate brigade. Joining in the Atlanta campaign with the army under General Sherman, the Fourth led the advance of the infantry and took part in all the engagements of the campaign in and around Atlanta.

The regiment formed a part of General Kilpatrick's force of 2,500 men in a raid south of Atlanta, and when the Union troops reached Flint River they found the enemy behind formidable entrenchments, but dismounted and, fighting on foot, charged him into Jonesboro.

Kilpatrick then marched for Lovejoy's Station to destroy the Macon Railroad. Here the Union forces were surrounded and, being outnumbered five to one, were in a critical situation.

Minty's Brigade was then massed by regiments and with drawn saber cut its way through the enemy's line, thereby securing the safety of the balance of the command.

After the fall of Atlanta, the Fourth was engaged in scouting, and detachments of the regiment had several severe encounters with the enemy. In October, when General Hood commenced his march north with the intention of taking Nashville, Tenn., the Fourth, with its brigade, followed in pursuit, and marching through Rome, Kingston and Resaca, Ga., met Wheeler's cavalry at Little River, Ala., on the 20th and drove the confederates five miles, killing and capturing a large number.

The regiment was sent to Louisville, Ky., to once more receive new equipments, and on the 28th of December started on the march for Nashville, where it arrived Jan. 8, 1865. Later in the month it marched to Gravelly Springs, Ala. Early in March the regiment started on a long raid through Alabama, meeting the enemy at numerous places, capturing guns and supplies, and arrived before Salma, April 2d, which was strongly fortified and defended by Forest's men, estimated at 9000.

The Fourth, with its brigade, was dismounted and assaulted the works, losing heavily in the advance, but, undaunted by the terrific fire, scaled the breastworks and with the balance of the command captured the city and 25 pieces of artillery, a large amount of ammunition and stores, besides 2800 prisoners.

The Fourth then marched through Montgomery to Macon, Ga., and the Union troops here received the surrender of Major General Howell Cobb, with his entire confederate force of 380 officers, 2000 men and 62 pieces of artillery, with all the arsenals, founderies and machine shops in the city.

It was here that the commanding General of the Union forces received the news of the surrender of Generals Lee and Johnson, which terminated hostilities east of the Mississippi.

It was soon learned that Jefferson Davis, president of the so-called southern confederacy, was trying to make his escape to the Atlantic coast.

Lieutenant Colonel Pritchard was directed by Colonel Minty to proceed with the Fourth to the Ockmulgee River and try to learn the whereabouts of Davis. Colonel Pritchard learned that Davis was moving towards Irwinsville, Ga., and, selecting 150 of his best mounted troopers, started in rapid pursuit. He found Mr. Davis encamped in the woods with members of his family and friends, and all were soon made prisoners.

The Fourth then returned to Macon, where Lieutenant Colonel Pritchard, Captain Hudson and Lieutenants Stauben and Purinton, with 22 men, were detailed to escort Mr. Davis to Washington, D. C.

A mere outline of the work done, the marches made, the hardships endured and the battles fought, as above written, only gives scanty justice to the results accomplished by such a regiment as the Fourth.

A work to be comprehensive as a regimental history would require a volume to chronicle the daily events of the regiment and its detachments. This volume is designed to give the military history of the enlisted men, as well as officers of the regiment, and only an outline sketch as to the movements of the regiment, which is the apology for the foregoing abridged history.

The regiment left Macon for home at the close of the war and reached Nashville, June 17th. On the 1st of July it was mustered out of service and returned to Detroit, Mich., July 10, 1865, where it was paid and disbanded.
