Letters New Orleans 12th April 1862 Immortal Isaac,

My glorious friend, how are you? Thank God that you came forth from the ordeal of death ever so safely as you did. I hope your wound is not severe or painful. God grant that it may not be. Mr. Jas. T Allyn had the kindness to send me a special dispatch announcing the welcome tidings of your safety. Yes, your safety, for it is a source of pride and pleasure to your noble soul to be wounded in defense of your country, and all thank God that you have come out of the fight so safely.

I took Allyn's message at once to the house. It made both your father and mother to feel at least twenty years younger. I saw your father the next day who said they all slept soundly last night because of the glad news from their son.

All were terribly exercised for your sake ever since the fight till that moment. Your mother was nearly crazy. Father, Mother, Aleck, Jane, Mary all well. They don't know I write to you this - will tell them first chance.

Have no fears for New Orleans, we are prepared for the enemy should he cross swords with us. The most formidable ram ever constructed is nearly completed here. The blockades at the mouth will soon hear from us. May freedom, glory and more laurels crown your efforts in the west.

God bless you, best love from my family - done up in haste- excuse everything and particularly your ancient obscure friend, Malony.

Tullahoma, Tenn. Jany [sic] 10th 1863 Dear Friend,

This is the first opportunity I have had to write since the fight. Thank God I came of it unhurt although in the hottest of it for 5 days I carried the colors of the regiment during the last four days.

Your kind letter of Nov. 22nd/62 came to hand. I saw your friend Mr. Johnson and told him to telegraph you that I was well and would write to you. I believe it was on the 2nd

Dec. I started a letter that day and got it about half finished when I was called away and never finished it. Since this is the fourth time I have commenced a letter to you and I hope to succeed this time in ending it. I hope you will forgive me for being so dilatory and unmindful of your kindness in not answering you.

We were kept very busy while in Murfreesboro. Being on the Provost Marshall's guard we were on guard every other day and where the Yanks advanced were sent out to the front. We went into the fight with 231 men and 24 officers and had 87 men killed and wounded, besides some 30 missing, supposed to have been taken prisoners.

Lts. [sic] Cenas, Trist, Kent and Barbarin were killed. Lt. Col. F.H. Farrar was wounded in the side with a shell supposed to be mortally. Lt. Reid, Capt. Trezivant and Lt. Perkins were also wounded.

The Yanks came near finishing the regiment on the evening of the 3rd day. They played us a Yankee trick. We were in a small strip of woods about half way between our lines and the enemy's on picket duty. And the Yank wishing to ascertain our positions sent over a flag of truce to recover the body of some officer that had been killed the day before. In the ambulance that accompanied the flag was an artillery officer taking items as we afterwards found to our sorrow. For as soon as the flag reached their lines they commenced shelling us at a terrible rate.

One of the first shells they threw struck Col. Farrar. Several of the men were also wounded. During the shelling a heavy line of battle advanced on us, (some 6 or 7000 men strong) and was not discovered until within about 30 feet of us.

Those that were able got up and dusted or in military parlance, fell back and the regiments that were supporting us. When they saw us come back, immediately broke and ran back to the breastworks, with the exception of the 19th Alabama which, along with what was left of ours, held the evening in check until the 9th and 41st Miss. advanced and supported us when we drove the Yanks back to their breastworks about 12 o'clock that night.

We commenced the work of evacuation and marched the balance of that night and all next day until we reached Shelbyville, a distance of 30 miles. I can tell you we have suffered a great deal during the last two weeks.

At present we are acting as Provost Guard in this place. I don't know what they intend to do with us. We are scarcely a hundred men strong now and there don't seem to be much a prospect of filling the regiment up.

I hope Gen. Bragg will break us up and put us into some other regiment so that we might get clear of these officers. I never had a very good opinion of them at anytime but since the fight they have become worse than ever they were. They are as cowardly a set of men as could be found. They were all drunk during the fight with one or two exceptions and could not be seen during any of the heavy fighting.

I heard from home sometime before I received your letter. I received short note from Mr. C.A. Janvier (Mr. McDowell's partner) dated Holly Springs, Oct. 18,1862 in which he stated that my Father and all the family were well. I was very glad to hear from home and will always be very thankful to you for any information which you may send me respecting the family.

I was sorry to hear that Ned Wilson met with an accident. Let me know whether he lost a leg or not. He may be better off than if he had been with the regiment, as he might have got killed in the fight. Give him my best respects. Also Allyn and Martin. I am glad to hear that your family are well and hope they may remain so while you are away from them. I hope this may find you enjoying good health as it leaves me.

I wish this war would end. I am commencing to get tired of it. I have went through more this last two weeks than I did in the whole of my life.

Give my love to Father, Mother, brother and sisters, Mrs. Molony and family. Write soon.

Tullahoma, Tenn. January 25th, 1863

Dear Friend,

I received your kind and welcome letter of the 5th inst. Day before yesterday, but not see the bearer of it (Mr. Bedenhamer) as I was on guard at the time. I thought that it was an answer to a letter I wrote you on or about the 13th inst. I directed it for Verona and it probably miscarried.

I came through the fight safe, thank God although I did not expect to be so lucky. The fight was very hot during the 31st but we drove them before us at every point until we came up to a strong position they had on the railroad from which we could not force them. We were under heavy fire opposite this for 3 or 4 hours when night put an end to the fight for that day.

On the 3rd inst. our regiment, about 250 strong, was sent out on picket in a small piece of woods about half way between our breastworks and the enemy's. The Yanks did not trouble us much until near dark when they commenced shelling us, which made us hug the ground closer then ever we did in our lives before.

Under the cover of this fire they sent out a line of battle about 5,000 men to dislodge us. They advanced to within about 30 yards of us before we discovered them and poured in a terrible volley. When the musketry opened there were three regiments supporting us.

They did not wait for us to fall back on them but immediately opened fire leaving us between two fires. We had to lay on the ground as we were and let the bullets of both of both sided [sic] pass over us.

The Yanks walked over several of our fellows thinking them dead. When they were driven back they took 20 of us prisoners.

In the five days fight we lost 81 killed and wounded and some 20 or 30 missing. Among the officers there was Lt. Censas, Trist and Barbarin killed. Lt. Col. F.H. Farrer and Lt. Reid wounded since reported dead.

Lt. Huger lost a leg and Capt. Trezivant and Perkins very slightly wounded. Our company was lucky in this fight. We had only 1 Lt. and 2 privates killed and the orderly Sergeant slightly wounded.

The regiment has been broken up since the fight. It is now called the 1st La Battalion, Major Strawbridge commanding. There are several of the officers to be court martialed for cowardice. Some of them will likely lose their commissions.

I am glad to hear that you are going to New Orleans and hope you may succeed. I will write a letter for home and enclose it in an envelope to you. I have made inquiries in reference to Mr. Ryan but could not find one that knew him.

I don't know any of the N.O. boys that were hurted [sic] in the late fight except one Wm. Dooley. He belonged to our baseball club. If you see or hear from him or Martin and Ned Wilson give them my respects and tell them that I am well. If you get home safe give my respects to Mrs. Molony and family and all inquiring friends.

I hope the war may end before you get back and that we may all meet at the old family board once more.

If you write again before you leave direct your letter to Sergt [sic] Wark, Co. "E", 1st La Batallion, [sic] Tullahoma, Tenn.

Camp, 1st Regt LA Infantry near Dalton, Ga. March 9th 1864 Friend Martin,

It is with lively pleasure that I take my pen in hand to answer your kind and welcome letter of the 7th and renew our friendship of former days. I often feel a curious sensation raise in my breast when I think of the happy days gone by when we used to run around playing ball, etc. And I can hardly credit it that I am a man, as these last three years seem more like a horrible dream to me than a reality, but a truce to sentimentalism.

I can't complain of any treatment as a soldier for we had had the best of times always though I think we will see the Elephant before many weeks roll over our heads. As from what I can glean, we are likely to be thrown into Adam's Louisiana Brigade and I can tell you that soldiering out in the front is not what it is cracked up to be.

There has been a rumor through this last few days that we will be sent to Mobile to man some of the Batteries there. We are so few in number now that those in power scarce know what to do with us.

Everything is quiet now in front, though last week we had a great hubbub and from the looks of things I thought we were going to skedaddle but Gen. Joe put a flea in their ear and they fell back; from the looks of things now I think we will soon be in the advance to pay Gen. Thomas a visit in Chattanooga and probably further in return.

I have never heard from you or James or Ned Wilson but once since I came out last. If you write to either of them remember me to them. I received a letter from Moloney about 4 or 5 months ago saying that he was going to run the blockade and I have not heard from him since, but I rec'd a letter from Alex and I think it was Moloney that brought it through as the directions on the letter seems to have been written by him.

I immediately answered Alex's letter and also wrote one to Moloney but have not rec'd an answer yet and as it is upwards of 3 months now I think the letter must have been miscarried or else he is not in Mobile.

If you have heard from him lately let me know and I write to him again as probably he may be paying me back in my own coin of not answering his letters promptly.

Martin Fay and Ed Michel are both here in Austin Battalion of Sharpshooters. Adams Brigade, and I believe both are well though I have not seen either of them this last couple of months. Tom Fox was in our regt. but was taken prisoner at the battle of Chickamauga.

I am glad to hear that all your folks were well, as also my own. When you write let me know how you get your letters through whether by Flag of Truce or through a private channel as I would like to write home but I'd hate to send a letter by flags for if I have to curtail my thoughts into channel as I would never get a letter written. I am bad enough as it is without any such hindrance.

I wish you could get time to come down here for a day or two as we could feast you royally on corn Dodger and Bull Beef. I would try and get down your way but I had a 2 day furlough to Atlanta about three weeks ago and I don't think they would give another so soon again, especially as I would be missed more now that formerly as I hold four different offices in the Regt. - that of Ordnance Sergeant, being the only one that I get

pay for though. I am acting Sergeant Major, Quarter Master Sergt [sic] and commissary Sergt. [sic] The men filling these different offices being absent, sick or prisoners.

I think it is about time to wind up as I did not intend to write so much when I started.
