

Jacob Ziegler Military Records

Biographical Information

1825-1897

JACOB ZIEGLER, one of Wood County's most prominent settlers, was born July 3, 1825 in Virginia and came to Texas about 1852, first settling at Oak Grove, where the Smyrna Church is now. He was married to a Miss Senter, who died in 1858. They had two daughters, Mary Jane Ziegler, who married a Hampton Bass, and Theodosie, who married John Oliver Carnes. In 1859, he married Elizabeth Ann Harry, and they had six children: Rachel Susan Ziegler Stanley, Elizabeth Ann Ziegler Spencer, Benjamin Franklin Ziegler, Nancy Lou Ziegler Whitley, Margaret Ziegler Ziegler and Josephone Ziegler Seay. A Baptist minister, Rev. Ziegler organized the Symrna [sic] Church in 1869, as well as numerous others in the area. He served in the Civil War, joining the Texas Cavalry Company 8, 10th Regiment. After the war, he served as Wood County Judge from 1865-1869. last Saturday, as a part of the Wood County Historical Society and Commission's Recognition Program, Rev. Ziegler's descendants presented his framed portrait (from which this photo was copied) to Wood County Judge Lee Williams to be hung in the courthouse. Many of his descendants, from both marriages, attended the program and reception at the First National Bank in Winnsboro:

Commanding Army and Division of West Mississippi, do hereby give my solemn parole of honor, that I will not hereafter serve in the Armies of the Confederate States, or in any military capacity whatever, against the United States of America, or render aid to the enemies of the latter, until properly exchanged in such manner as shall be mutually approved by the respective authorities.
