Public Workshops Coming This Spring

Tell us how you think the trail and byway should develop

Last November, many of you participated in the first round of workshops and gave us your ideas for trail opportunities, important sites, and visitor experiences on the trail. We have used your input to draft several alternatives for how the Star-Spangled Banner National Historic Trail and Byway will develop and be managed over the next twenty years. At the workshops this spring, we will share these alternatives and ask for your preferences. Your input will help us develop a strategy for trail development that incorporates the opinions and preferences of residents and partners in Maryland, Virginia, and the District of Columbia. This fall, we will circulate a draft comprehensive management plan containing the preferred alternative and ask for your review.

Your input is greatly appreciated and important to us. The Star-Spangled Banner National Historic Trail and Byway will best serve the public when it reflects the best ideas of the people who live here. An announcement about workshop locations and dates will be made soon.

Virginia War of 1812 Heritage Trail Legislation Passed

The Virginia legislature has passed [a bill](#) to establish The Virginia War of 1812 Heritage Trail. The trail would utilize the historic marker program as a catalyst to link locations and sites significant to the American War of 1812 to highlight and commemorate Virginia's role, participation, and contributions to the success of the war.



The legislature also authorized the issuance of [special license plates](#) marking the bicentennial. Proceeds of sales will support the operation and programs of the Virginia Bicentennial of the American War of 1812 Commission.

Public Art Project

The Maryland State Arts Council will receive "Requests for Qualifications" for the [Francis Scott Key Bridge Public Art Project](#) until March 18, 2011. This large-scale interpretive project is open to artists and professional design teams (including artists, designers, artist-led team, architects, landscape architects, etc.) located in the United States. The Key bridge spans Baltimore's harbor near the spot where Key witnessed the bombardment of Fort McHenry on September 13-14, 1814. The bridge provides travelers a panoramic view of Baltimore harbor and will serve as a gateway for an international flotilla of gray hulls and tall sailing ships arriving in June 2012 to kickoff the national bicentennial in Maryland. The Maryland War of 1812 Bicentennial Commission is coordinating the Key Bridge Public Art Project with the Maryland State Arts Council and the Maryland Department of Transportation.

Maryland War of 1812 Bicentennial Commission unveils fundraising efforts for Star-Spangled 200



In tandem with the opening of the new Fort McHenry Visitor Center, the Maryland War of 1812 Bicentennial Commission announced the launch of a \$25 million campaign to fund events commemorating the 200th anniversary of the Star-Spangled Banner and Maryland's role in the War of 1812 and to enhance the historical and cultural resources associated with the war.

The Commission has designated the not-for-profit Star-Spangled 200, Inc. (SSB200) as the entity that will lead its fundraising efforts through corporate and individual donations. The Commission and SSB200 will also coordinate to leverage revenues received from the minting of a commemorative coin by the U.S. Mint.

President Obama signed the Star-Spangled Banner Commemorative Coin Act into law August 16, 2010. Available in January 2012, the sale of the coins could provide up to \$8.5 million for bicentennial events and legacy projects. The dollars raised from the coin sales are only available on a one-to-one matching basis.

"The commemorative coin dollars are only part of a total campaign to raise \$25 million to elevate Maryland globally as a premier location to live, work and visit during this once-in-a-lifetime opportunity," said Governor Martin O'Malley. "These dollars will be contributed by the corporate community and individuals that are invested in celebrating Maryland's pivotal role in American history."

The SSB200 also unveiled its new website, www.starspangled200.com, where it will announce bicentennial celebration updates, enable donations, offer bicentennial merchandise, and more.
