The coordinating entity is the federally appointed Erie Canalway National Heritage Corridor Commission (Commission) and its non-profit partner the Erie Canalway Heritage Fund, a 501(c)3 organization in Albany, New York. The Commission provides a framework to assist the State of New York and its units of local government (including 23 counties and 230 municipalities) along the 524 navigable miles of the Erie Canalway, in the development of integrated cultural, historical, recreational, economic, and community development.
