

Stephen T. Mather Training Center
Interdisciplinary Resource Protection and Law
Kailua-Kona, Hawaii
May 12 – 16, 2014
May 19 – 23, 2014

This forty-hour interdisciplinary course provides employees with a solid understanding of the resource mission of the NPS and the primary laws, legal authorities, case law interpretation, and policies used to protect park resources. Participants will also receive instruction in the functions and roles that contribute to effective interdisciplinary group work and practice these skills through resource protection case studies.

Training focuses on the ability of the employee to recognize a diversity of natural and cultural resources existing throughout the national park system and the types of threats and vulnerabilities associated with these resources. Participants utilize the legal basis (including compliance) for resource protection and develop skills and strategies to respond and take action to prevent resource injuries through interdisciplinary collaboration. Methods for implementing resource protection, visitor education, and visitor management techniques are explored. Participants will leave this training with the basic level knowledge required to apply legal authorities to safeguard natural and cultural resources, an understanding of the broad range of threats to park resources, and strategies to recognize, respond, and take action to resource impacts. Participants will gain experience using interdisciplinary group processes to ensure effective collaboration among NPS staff, partners and the public. **Participants will be required to complete pre- and post course work to receive full credit for the course.** Part of the post-course work will include developing an outline of a response plan SOP for a resource injury. Law enforcement refresher credit hours are available (28.5 hours) for this class.

Course Objectives:

Develop a comprehensive knowledge of the environmental and legal framework that safeguards natural and cultural resources in the National Park System.

- Develop a working knowledge of the environmental and legal framework that safeguards natural and cultural resources in the National Park System.
- Recognize that knowledge of park resources is central to each employee's duty of protecting those resources.
- Understand that resource protection, prevention, and visitor education are important components of taking action to ensure resources are protected in park unit daily operations.
- Demonstrate group processes to ensure effective interdisciplinary and cooperative actions among NPS staff, partners, and the public.
- Use an integrated approach to identify threats to park resources for the purpose of ensuring that resource injuries are correctly acted upon.

Participants: This course is recommended for **commissioned employees, interpreters in resource education and public information, resource management discipline specialists, and facility management employees** who will work in interdisciplinary teams. Other disciplines are encouraged to apply. Law enforcement refresher credit hours are available (28.5 hours) for this class.

Class size is a maximum of 30 participants. **Priority will be given to employees from the Pacific Island network.** Employees from Pacific West and Alaska Region parks may apply, but must pay travel from the benefitting account. Applications from other regions and mainland offices will not be accepted.

Dates: **There are 2 separate classes.**
Class #1: **May 12 - 16.** Travel dates are Sunday, May 11 & Friday, May 16, after 5:00 PM.
Class #2: **May 19 - 23.** Travel dates are Sunday, May 18 & Friday, May 23, after 5:00 PM.
Both classes start at 8:00 AM on Monday and conclude at 4:00 PM on Friday.

Location: Kailua-Kona, Hawaii. Lodging information will be provided to participants after selection.

Travel Cost: No Tuition. Lodging, M & IE, airfare up to \$400, and incidental travel expenses and travel ceiling **for Pacific Island employees** will be **provided by Mather Training Center.** **Employees from Pacific West and Alaska Regions will be responsible for their own travel expenses.** Lodging is \$119; M & IE is \$110. Total daily cost = \$229.

Application: **Applications close April 9.** Apply through DOI Learn at: <http://www.doi.gov/doilearn/index.cfm>. On the "Welcome" page, click on "Search the Catalog" near the center of the page. Search on "Interdisciplinary Resource Protection." There are two separate sessions. **Apply for only one.**

Supervisory approval is required for all courses. Registrations are not considered complete without supervisory approval. Please ensure that your current supervisor's name appears in the approval block in DOI Learn before completing the registration process. You will not be considered for the class if your supervisor has not approved you by the closing date, **no exceptions.**

Once approved by your supervisor, **you will receive an email confirming that you are "Wait Listed"**. You will be notified of your selection to participate in the class and receive logistics details in an email by April 11.
