



Climate Fundamentals Academy New England - Training Workshop #2

Cambridge, MA

May 24 - 25, 2016

The Climate Fundamentals Academy is a 3-part series of 2-day training workshops presented by the [Association of Climate Change Officers](#) (ACCO). The [Climate Fundamentals Academy](#) enables attendees to satisfy all course requirements for the Climate Governance Certificate, a credential issued through ACCO's CCO™ Certification Program. This is the second workshop of the series; the final workshop will take place in the summer/fall of 2016. Participants are welcome to attend one or all workshops in the series. Tuition will be paid for interested NPS employees.

This workshop provides participants with a foundation for understanding greenhouse gas emissions and related reporting and disclosure frameworks; strategies for engaging stakeholders and leading organizational change; assessing the legal and policy landscape; and examining the economic implications of climate change. Participants will learn about specific initiatives in their localities, states and regions, as well as relevant national and international activity

WORKSHOP #2 OBJECTIVES:

- Describe the implications of climate change with an added regional focus
- Explain greenhouse gas emissions and related reporting and disclosure frameworks
- Identify strategies for engaging stakeholders and leading organizational change
- Articulate the process to assess the legal and policy landscape
- Examine and describe the economic implications of climate change

TARGET AUDIENCE: Park Superintendents and Senior Managers, Natural and Cultural Resource Managers, Facilities Management Personnel, Park Planners, Interpretation, Education, and Communication staffs.

LOCATION: Massachusetts Institute of Technology, Cambridge, Massachusetts *Note: Similar opportunities are expected to be held in Chicago, San Diego, San Francisco, and the National Capital Region in 2016.*

DATES: May 24 – 25, 2016. Class is 8:00 AM-6:00 PM both days.

TUITION: FREE, under an agreement with ACCO.

TRAVEL COSTS: Travel paid by benefitting account. Lodging is \$247; M&IE is \$69. Participants are responsible for finding their own lodging.
