



Whiskey Creek Group Picnic Area

There are three designated group sites in this day use picnic area, which is located on the northeastern shore of the Whiskey Creek arm.

Alcoholic beverages are prohibited in this area.

Dogs or other pets are not allowed.

Each site contains a large charcoal barbecue grill, two large serving tables surrounded by smaller tables for seating, and garbage cans. Open fires are not allowed.

There is one restroom with vault-type toilets. Drinking water and electricity are not available.

Boats may be launched from the Whiskey Creek Launch Ramp directly across the lake and may be moored on the picnic area shoreline. All groups holding a reservation share the beach area.

There are trees in the area that provide light shade, but portable shade structures are recommended on hot days.

Reservations and Fees

Reservations are required from April 1 through October 31. The area is closed between November 1 and March 31.

Reservations can be made up to six months in advance by calling **1-877-444-6777** or by using the Internet address: www.recreation.gov

Site #1 has a minimum of 20 people and a maximum of 80 people, although only 50 people can be seated at the picnic tables at one time. Site #1 costs \$50.00 per day.

Sites #2 and #3 each has a minimum of 20 people and a maximum of 40 people, although only 30 people can be seated at the picnic tables at one time. Site #2 and #3 each cost \$40.00 per day.

All three sites can be rented at one time for \$130.00 (160 people maximum).

Regulations

- 1. Alcoholic beverages are prohibited in this area.**
- 2. Dogs or other pets are not allowed in the picnic area.**
3. No more than 80 people are allowed in site # 1. Sites # 2 and # 3 allow only 40 people each.
4. Open fires are not permitted.
5. Area hours are from 9 AM until dark. Park Rangers clear the area at nightfall and lock the gate for the night.
6. Vehicles are prohibited in the picnic area except to load or unload equipment. All vehicles must be removed to the dirt parking lot.
7. A gate controls access to the area. Please close the gate behind you as you enter and leave the area. Do not lock the gate, as only a park employee can unlock it.
8. All groups holding a reservation share the beach area.
9. Vehicles parked outside of the Whiskey Creek Group Picnic Area are subject to the \$5.00 Daily Use Fee. Permits may be purchased at the Whiskey Creek Launch Ramp Pay Station.
10. Protect our natural resources. Do not put nails in trees or damage or remove vegetation.
11. Dispose of all trash properly. Put all leftover food, beverage containers, plates and utensils inside the bear proof garbage cans and make sure that the latch is secure. If you have more trash than will fit inside of the bear proof cans, please take the excess with you when you leave so that bears will not be attracted to it.

Bears that get human food sometimes become aggressive and dangerous and must be killed. You can prevent this by proper food storage.

Please help keep all wildlife healthy and wild by not feeding them or allowing them to get into your food or trash.

Report all bear incidents to the Visitor Center.

Citations

A law enforcement ranger may issue a citation for \$150 if you do not store your food properly.

Feeding wild animals is against the law and may result in a citation of \$250.
