Subsistence ORV Permit Instructions

IS THIS THE PERMIT I NEED?

Subsistence Off Road Vehicle (ORV) users are qualified local, rural residents who may use ORVs to engage in subsistence activities on park and preserve lands, including in designated wilderness, within Wrangell-St. Elias. Find out if you qualify here.

This permit only covers users who are actively engaged in subsistence activities. If you wish to also use an ORV in the park or preserve for recreational activities, you must obtain an additional Recreational ORV Permit.

APPLICATION INSTRUCTIONS FOR SUBSISTENCE ORV PERMITS

- 1. Download ORV application (form 10-933) from the Subsistence ORV website.
- 2. Complete the application, including **Applicant Information**, **Vehicle Information**, **Permit Request Details**, and **Name**, **Date**, and **Signature**.
 - a. Use your physical address for your primary permanent residence in the applicant information section.
 - b. If the permit will cover more than one ORV, use addendum (last page of application) to add additional vehicles.
- Email the completed application (form 10-933) to WRST_Permits@nps.gov
 (WRST_Permits@nps.gov). The email subject should say "Subsistence ORV Permit."
- 4. Permitting staff will process the application. If/when the application is approved, the applicant will receive an email with the *unsigned ORV permit* (form 10-114) attached.
 - a. Sign and date the permit (page 1 of form 10-114).
 - b. Designate the **person who is responsible** for adhering to the permit terms and conditions. This can be the permittee or another person. (Condition #12 on page 3 of form 10-114).
 - c. Return the permit to WRST_Permits@nps.gov (WRST_Permits@nps.gov).
- 5. Permitting staff will email the *official (fully executed) NPS-signed permit* to the permittee.
- 6. The person designated under Condition #12 (and any additional ORV drivers in the party) must keep the signed ORV permit on their person (hard copy or digital copy) at all times while operating an ORV on designated trails listed on the permit in Wrangell-St. Elias National Park and Preserve.

NOTES

- Please allow two weeks processing time from the date the application is first submitted until an official permit is received.
- The permit is not valid until signed by both the permittee and NPS official.
- Always keep a copy of the permit on your person (hard copy or digital copy).
- The permit is only valid for the year it is issued.
- To minimize resource damage, it is recommended that subsistence ORV users travel on established trails and dry riverbeds.
- Some areas of the park and preserve have further restrictions. These are described on the Subsistence ORV Use webpage and outlined in the "Park-specific Terms and Conditions" (#22 and #23) on the Subsistence ORV Permit.

IMPORTANT NOTICE TO APPLICANT

This application does not serve as permission to conduct any special use activity in the Park. The information provided will be used to evaluate whether a permit will be issued. All applicable parts of the form must be completed. Incomplete applications will not be evaluated. Send the completed application to wrst_permits@nps.gov. The application must be signed and dated in order for the application to be considered complete.

Purposes The purposes of this application are (1) to provide a National Park Service (NPS) Park Superintendent with information to approve or deny requests for activities that provide a benefit to an individual, group, or organization, rather than the public at large; and (2) to assist Park staff to manage the activity to ensure that the permitted activity does not interfere with the enjoyment of the Park by visitors and that the natural and cultural resources of the Park are protected.

Routine Uses: In addition to those disclosures generally permitted under Title 5 U.S.C. § 552(a)(b) of the Privacy Act, records or information contained in this system may be disclosed outside the NPS as a routine use pursuant to Title 5 U.S.C. § 552(a)(b)(3) to other Federal, State, territorial, local, tribal, or foreign agencies and other authorized organizations and individuals based on an authorized routine use when the disclosure is compatible with the purpose for which the records were compiled as described under the system of records notice for this system

Effects of Nondisclosure: Failure to provide the requested information may impede your ability to obtain a permit from the NPS. The U.S. Criminal Code, Title 18 U.S.C. § 1001, provides that knowingly falsifying or concealing a material fact is a felony that may result in fines of up to \$10,000 or 5 years in prison, or both. Deliberately and materially making false or fraudulent statements on this form will be grounds for denying you a Special Use Permit.

If your request is approved, a permit containing applicable terms and conditions will be sent to you. The permit must be signed by the responsible person and returned to the Park for final approval by the Park Superintendent before the permitted activity may begin.

CUSTOMERS MAKING PAYMENT BY PERSONAL CHECK

When you provide a check as payment, you authorize us either to use information from your check to make a one-time electronic fund transfer from your account or to process the payment as a check transaction. When we use information from your check to make an electronic fund transfer, funds may be withdrawn from your account as soon as the same day we receive your payment, and you will not receive your check back from your financial institution.

PAPERWORK REDUCTION ACT STATEMENT
