HISTORY

Charles Jesse Jones or "Buffalo Jones" as he was later nicknamed, was born January 31, 1844, in Illinois and died in 1914 in Topeka, Kansas. As an adult he became a staunch supporter and activist for protecting the American bison. Despite his work in preservation, Jones began his career as a hide hunter where he experienced firsthand the depletion of the bison herds. It was also during this time that Jones developed techniques to capture wild animals without killing them. He became a personal friend of Theodore Roosevelt, who appointed him the first game warden of Yellowstone National Park. Jones's techniques were used to quell rising bear problems as well as working to support the preservation of buffalo within the park.

Jones purchased as many bison as possible within North America and raised them on his ranch, even succeeding in taming and training many. "Cattelo," or a crossbreed between cows and bison, were another successful product of Jones's ranch. Later in his life, Jones traveled to Africa (1906 and 1914) to practice his "live capture" techniques on the game there. Lassoing lions was of particular interest to the public- and stories were written about his adventures; Jones himself often gave lectures to the public.

DESCRIPTION	This collection includes personal and business correspondence, photographs and a brochure which pertain to his work as an adventurer, speaker and activist on both the North American and African continents. There is also an incomplete memoir of his time as the first game warden of Yellowstone National Park
	The photos and correspondences within this collection represent C.J. Jones's time working at Yellowstone and his trips to Africa. The collection includes photographs of bison in North America and copies of photos from Africa. Personal letters to family and friends as well as business oriented correspondence are part of this collection. There is also an unpublished, unfinished memoir written by Jones and edited by his daughter, which gives information about time spent in Yellowstone as well as copies of advertisements for a trip to Africa.
	The correspondence includes personal letters from Jones to his daughters, Olive and Jessie, sent from different hotels in New York City during the early 1900s, a letter to Jones from Theodore Roosevelt and a publisher's correspondence pertaining to Jones writing an article for the magazine. Photographs include those from Yellowstone as well as copies of photos from Jones' trip to Africa to capture live animals to Africa to capture live animals.
ORGANIZATION	The collection is arranged into subject files. Photographs can be found in two folders, Yellowstone and Africa and Publicity. Two glass plate negatives have been separated from the collection and placed in cold storage.
PROVENANCE	Purchased from Todd Whitmer in 1999, Whitmer is a descendant of Jones. Additional materials were photocopied with Whitmer's permission.
