*DESCRIPTION* Approximately 200 photographic slides of trips to Yellowstone, 1941-1949, primarily depicting landscapes.

The collection consists of approximately 200 color photographic slides of the Caustin family's six trips to Yellowstone between 1941 and 1949. The images focus on the landscape, plants, and wildlife of Yellowstone.

Wildlife depicted include antelope (pronghorn), bears (black and grizzly), bighorn sheep, bison, Canadian geese, cormorants, coyotes, deer, elk, great gray owls, gulls, moose, pelicans, rocky mountain jays, and swans.

Photographs of thermal and other natural features include Black Sand Basin, the Grand Canyon of the Yellowstone, Fishing Bridge, Gibbon Geyser Basin, Heart Lake Geyser Basin, Lonestar Geyser, Upper and Lower Falls, Lower Geyser Basin, Madison Junction, Mammoth Hot Springs, Midway Geyser Basin, the Mud Volcano area, the Norris area, Old Faithful, Shoshone Geyser Basin, Specimen Ridge, Tower Falls, Undine Falls, Upper Geyser Basin, West Thumb Geyser Basin, and the Yellowstone Lake area.

The plants featured in the slides include algae, bistort, camas, cinquefoil, forget-me-nots, fringed gentians, Indian paintbrush, lupine, Siberian onions, and yellow monkey flowers.
