HISTORY

The National Park Service has used several different filing systems since it was created in 1916. Prior to 1953, the National Park Service used a subject based decimal file code system. The present filing system is alpha-numerical and groups all records into one of twelve broad series based on subject matter. These series are: A-Administration and Management; C-Concessions; D-Development and Maintenance (Planning); F-Fiscal; H-History and Archeology; K-Interpretation and Information; L-Land and Recreation Planning; N-Natural and Social Sciences; P-Personnel; S-Supplies, Procurement and Property; W-Laws and Legal Matters; and Y-Forestry and Fire Management.

The various series then use an alpha-numeric system of file codes to abbreviate lengthy file titles. In the National Park Service system there is a series key letter (ranging from A to Y) followed by a set of even numbers to represent the title of the subject file and a set of odd numbers to denote a sub-title to further define the subject of the file. These codes are then used in conjunction with the National Park Service's records retention schedule to determine if a record is to be kept permanently or only temporarily and then destroyed.

In this collection, all records designated as permanent were kept along with those temporary records of sufficient age or uniqueness to have considerable historic value.

Management of fiscal and supply issues has been part of the Yellowstone National Park's administration since it was created in 1872. The fiscal and supply records pertaining to the Park during the United States Army's era of administration, 1886 to 1917, are in a separate collection and not present in this collection. Since the National Park Service was founded in 1916, responsibility for handling the Park's fiscal and supply matters has varied over time and is documented in the records themselves. In more recent years, budget development and procurement of supplies has been partially distributed to the various functional units within the Park so fiscal and supply records related to specific programs, units or divisions may also be found in the respective associated record groups.

Although all Personnel records are only considered temporary, records containing lists of Yellowstone Park staff were kept along with a unique collection of World War II era newsletters pertaining to the Park and sent out to Park staff members serving in the military. While these staff lists and newsletters were retained, inactive Official Personnel Folders (OPFs) of former federal employees are managed by the National Personnel Records Center in St. Louis, Missouri, and are not included in the park archives.

DESCRIPTION	This record group contains documents that relate to the fiscal, personnel, and supply aspects of Yellowstone National Park.
	The Fiscal Series contains records that document the financial management of the park including budget formulation and execution, audits, fees, revenues, expenditures and appropriations.
	Records in the Personnel Series concern employment, position classification, recruitment, certification, training, compensation, promotions, evaluations, and appointment procedures. There are also Yellowstone National Park specific employee handbooks.
	Records in the Supply Series relate to the acquisition of supplies and property, inventory lists, the purchase of supplies and contracts for various projects and services. There are also records relating to the acquisition, inventory, operations, and usage of the corrals and head of stock.
ORGANIZATION	Organized into three series: Series I, Fiscal Records; Series II, Personnel Records; Series III, Supply Records.
PROVENANCE	These records were created by various departments within Yellowstone National Park and accessioned by the National Archives and Records Administration (NARA) before being placed on deposit at its affiliated repository, the Yellowstone National Park Archives, prior to September 2000. SERIES DESCRIPTIONS

I. Fiscal Records, 1917-1999 (bulk dates: 1929-1954)

Files are grouped together using the alpha-numeric file coding system. This series also includes several bound ledgers.

This series consists of proposals by Yellowstone Center for Resources (YCR), expenditure records for roads and trails, cost statements for the park's several mess halls, records discussing the costs to maintain grizzly cans and fisheries, and budget development, including budgets for the Yellowstone Park School. Also of interest are correspondence between the NPS and Yellowstone during WWII discussing cost cutting measures and expenditure records for Mrs. Nixon's 1973 visit to Yellowstone. There are also several audit books and receipts as well as photographs supporting proposals for spending and additional funding.

II. Personnel Records, 1918-Present (bulk dates: 1928-1953)

Files are grouped together using the Pre-1953 numerical file coding system.

This series consists of personnel lists from 1918 through the present, job descriptions, employee handbooks, some income records, correspondence requesting information about jobs, and records of veterans in employment. While the personnel lists include permanent, term, and seasonal staff, they do not appear to include some casual or on-call labor such as early fire crews, with the exception of one 1928 ledger of employees that has been identified as most likely the season's fire crew. There are also letters of encouragement to Yellowstone employees serving in the military during WWII and a directory of Yellowstone families from 1977. Most records from the 1960s-1970s are absent from the collection.

III. Supply Records, 1925-2012 (bulk dates: 1954-1986)

Files are grouped together using the alpha-numeric file coding system.

This series contains ledgers detailing the costs and procedures of caring and feeding for ranger's horses as well as records pertaining to the sale of these horses and operations of the corrals, contracts awarded to various companies to do construction within the park from 1954-1959 and 1960-1962 as well as records of the methods used to advertise contract jobs, a chart of passenger car costs from 1933, records of long distance phone calls and snow plow maintenance records. There are also photographs and press releases about corrosive thermal water within the park.
