Camping and Lodging

The Tuolumne Meadows Campground would be retained across all of the alternatives, with varying levels of capacity. The capacity at Tuolumne Lodge and Glen Aulin High Sierra Camp would vary between alternatives:

Parking

In each of the alternatives, informal roadside parking would be eliminated to improve hydrologic and ecologic function of the meadows. The number of formalized spaces would vary between alternatives, with some parking areas being expanded, combined, moved, eliminated or reduced in capacity.

The number, size, and location of visitor services would vary between alternatives.

User and Administrative Capacity

The overnight capacity in the river corridor would be determined by the number of campsites at the campground, beds at the lodge, wilderness permits, and capacity at Glen Aulin while the number of day use visitors would largely reflect the number of parking spaces available. The numbers of park employees would also vary between the alternatives reflecting the range in visitor services.
