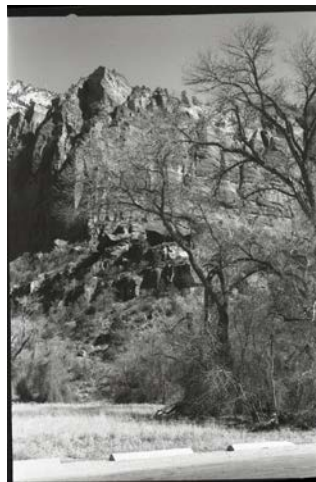

## ***HISTORY***

The Lee Land Exchange Survey, Resource Management Project Number 99-04, was conducted between October, 1998-April, 1999. The project intended to exchange approximately 2,000 acres of Bureau of Land Management (BLM) administered land for 1,250 acres of private land within Zion National Park. This investigation focused on the identification of cultural resources within the area of potential effect; the evaluation of identified resources against the eligibility criteria for inclusion to the National Register of Historic Places; and an assessment of effects to historic properties that could result from the proposed undertaking. 43 archeological sites and 68 isolated finds were recorded. Three of the sites contained historic period components, related to ranching and livestock grazing in the area. Additionally, two loci of previously recorded site 42Ws 1813 were identified and recorded. One of the newly recorded sites, 42Ws 3769 was evaluated as being eligible for inclusion to the National Register of Historic Places, under criterion D. The remaining sites were recommended to be ineligible for inclusion to the National Register.
