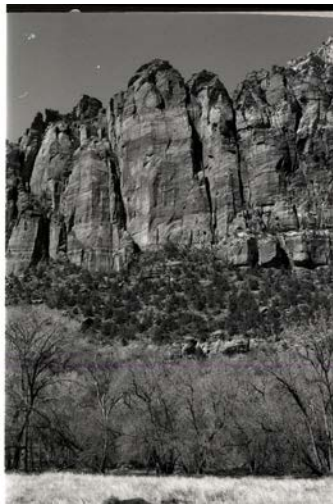

## ***HISTORY***

Wildcat West Burn Unit Archeological Survey: Cultural Resource Survey of 1280 acres of Zion National Park land located on the Upper Kolob Plateau, Utah. Resource Management Project Number 99-03, State Historic Preservation Office (SHPO) Project Number U-99-NA-0535n.

A century of fire suppression activities has resulted in the accumulation of hazardous fuels throughout many areas of Zion National Park. To combat this hazard, Zion has developed a program to reduce the fuel loads through controlled, prescribed fires. Since the prescribed fire and related activities had the potential to affect historic properties a survey of cultural resource was undertaken. An archeological survey was conducted within an area of approximately 1280 acres (750 acres could be intensively inventoried), located in the northwestern portion of Zion National Park on the Upper Kolob Plateau. Two new sites (42WS3916 and 42WS3917) and 17 isolated occurrences were recorded during the survey. Both new sites are open prehistoric lithic scatters with no identifiable features. Field work was conducted between June 9 and 16, 1999 by Wade Kaiser and Nikole Christianson with volunteer Andrea Perez, under the supervision of archeologist Mathew Betenson.
