



## Watchman Campground Rules and Regulations

Reservations for Watchman Campground (late February through November) can be made at [www.recreation.gov](http://www.recreation.gov), by calling 1-877-444-6777, or in person at the campground. **Reservations may be cancelled, without refund, if campsite is not occupied by 11:00AM on the day after your scheduled arrival or if the site is unoccupied for 24 hours.**

### Camping Etiquette

- Check out time is 11:00AM Mountain Time.
- Quiet hours are 10:00PM to 8:00AM.
- Generators are not permitted at any time.
- Tents and vehicles must remain within campsite boundaries and cannot be on vegetation.
- Do not move picnic tables.

### Campground Use Limits

- Six (6) people maximum per campsite, including children.
- 1 RV per campsite *max height 12'6"* (3.84m) (RV, 5th wheel, camper trailer, cabover, camper van, etc.).
- Maximum 2 vehicles per site, trailers are considered a vehicle. 4 motorcycles are allowed if no other vehicles.
- C and D Loops will only accommodate vehicles with a combined length *less than 19'* (5.8m).
- Maximum number of tents per site is 3.
- Length of stay is limited to 14 total days per person during the reservation season and 30 additional days December to February.

### Vehicle Parking

- All vehicles, including trailers, must be kept in parking areas, *not on vegetation*.
- Overflow parking is available at the amphitheater in B loop, in South Campground amphitheater parking lot and in the Zion Canyon Visitor Center parking lot.

### Food Storage and Sanitation

- *Food must be stored in a vehicle or hard-sided lockable container.* Feeding wildlife is prohibited.
- Bathing and washing at public faucets or in restrooms is prohibited.
- Black water must be disposed of at the dump station, not on ground, in the river, or in the irrigation ditches.
- Grey water (dishwater and solar shower) must be dumped down drains near the water spigots outside each restroom or at utility sinks at the restrooms. RVs may dispose of grey water at the dump station.
- Do not leave trash unattended. Dispose of trash in dumpsters. Leave campsites and fire rings free of litter.
- If using a solar shower, water must be collected and dumped down drain at restrooms.
- Dishwashing is allowed in the **outdoor** sink at each restroom.
- Recycling stations are located throughout the campground.

### Fires and Firewood

- *Wood gathering is prohibited* throughout the Park.
- Check with a park ranger or campground host for information on periodic fire restrictions during the season.
- Fires are allowed in fire rings at each site. Select sites in F loop do not have fire rings.
- Do not leave fires unattended.
- Fireworks are prohibited in Zion National Park.

### Pets

- *Pets must be restrained* at all times. Leashes must be no longer than six feet.
- Pet owners must pick up and properly dispose of pet excrement.
- Hiking with pets is allowed only on roads and the Pa'rus Trail.
- Unattended pets making unreasonable noise are prohibited.

### Recreational Equipment

- Attaching or suspending any item from trees which may cause damage, including swings, candles, and lanterns, is prohibited. Use of nails, wire or chains is prohibited.
- *Hammocks* are only allowed in the *footprint of the campsite*. They cannot hang over vegetation.
- Hammocks are not allowed in the group sites.
- Bicycles are allowed only on the paved Pa'rus Trail and park roads.
- In-line skates and non-motorized scooters are allowed only on campground roads and Pa'rus Trail.
- River tubing and skateboarding are prohibited.
- Installation and or use of any sports equipment that would cause resource damage is prohibited--e.g. slacklines, horseshoes, volleyball nets, etc.
- Clotheslines may be no longer than 15 feet and are restricted to one clothesline per site.
- Use of firearms is prohibited.
- Use of OHVs and ATVs is prohibited in the campground and park.

### Walk-in Sites F Loop

- *Food storage boxes are provided* at each campsite. All food and garbage must be kept secure in the storage box, a hard-sided container or your vehicle.
- All tents must stay on established tent pads. Sites will accommodate 1 medium tent or 2 small tents.
- All campsite activities (cooking, congregating) must stay within the delineated area.
- Sites do not accommodate the gathering of large groups within one site. You may use the common campfire areas for congregating near sites 7 and 15.
- If your campsite does not have a fire pit you must use the communal fire pit.
- Picnic tables may not be moved out of the campsite.
- There is only one designated parking stall for each campsite. Additional vehicles will need to park in overflow parking areas. See ranger at kiosk for additional parking areas.
- Please remain within delineated areas of each campsite and on designated paths.
