



Commercial Tour Groups

Fees

Entrance fees for multi-day tours with the same passenger manifest are valid up to seven days.

Vehicles exceeding 7'10" wide and/or 11'4" high require traffic control through the tunnel. The permit fee for oversized vehicles is \$15 and is valid for two trips through the tunnel within seven days.

Vehicle Capacity	Entrance Fee
1 to 6 passengers	\$35 plus \$12 per person, not to exceed \$70
7 to 15 passengers	\$70
16 to 25 passengers	\$80
26 or more passengers	\$190

Tunnel "Escorts"

In summer, tunnel escorts are available from 8:00 a.m. to 8:00 p.m. daily. In winter, tunnel escorts are by request only and must be arranged prior to proceeding to the tunnel. Arrangements can be made at entrance stations, the Zion Canyon Visitor Center, Zion Human History Museum, Zion Lodge or by calling 435-772-0178.

The speed limit through the tunnel is 25 miles per hour, and the minimum speed limit is 15 miles per hour. To avoid delays, buses may not stop inside the 1.1 mile-long tunnel or travel slower than the minimum speed limit. Violators will be cited.

Parking

Shuttle Season (late March - mid November)
The Zion Canyon Pedestrian Entrance parking area in Springdale is the most convenient place to park a bus for access to the visitor center and shuttle buses. If entering from the East Entrance, present your entrance receipt at the Pedestrian Entrance for park admission.

1-15 Passenger Vehicles (Vans/Sedans): Not permitted on the scenic drive.
16+ Passenger Vehicles (Mini-Buses/Motor Coaches): Permitted to park in the following locations, space permitting. 1) Designated bus parking spaces at Zion Lodge if the group has a planned activity at the Lodge. No vehicles are permitted beyond the Lodge. 2) Designated bus parking spaces at the Zion Human History Museum. Loading or unloading is not permitted in front of the museum. 3) Paved pullouts between Canyon Junction and the tunnel as long as the vehicle fits completely within the pullout. 4) Checkerboard Mesa. Bus parking or stopping in any other than these locations between April and October is not permitted. From November through March, buses may also park at the Grotto Picnic Area and the Temple of Sinawava.

Buses must not idle their engines when parked as it creates unacceptable amounts of noise and air pollution.

Trail Use

Company representatives or guides may not accompany clients on park trails. A Commercial Use Authorization is required for companies wishing to accompany clients on the park shuttle, on trails or into any off-road areas. For companies without a Commercial Use Authorization, interpretive services are permitted inside the vehicle and at roadside pullouts only.

Dump Stations

Buses may not use the dump stations at the campgrounds. These stations are for the patrons of the park campgrounds only and do not have the capacity to store the additional waste from tour buses.

Kolob Canyons

The visitor center restrooms cannot accommodate tour buses. Please have your clients use the on-board restroom or the rest stop four miles north on I-15. Parking is limited to the Kolob Canyons Visitor Center and Timber Creek Overlook. Hiking is limited to the Timber Creek Trail. No other trails are permitted.
